

Be Prepared

When planning bus trips this winter, check

LTD.ORG or the Rider's Digest for a blue
snowflake symbol displayed on
the route. This indicates that
on snow or ice days, the route
could be delayed or detoured. Standard
snow and ice detour maps are available
online at LTD.org or at the Customer Service
Center at the Eugene station. When snowy or
icy conditions hit the region, up-to-the minute
notice will be posted regarding bus routes or
detours. The LTD website and Twitter (@LaneTransit)
will be updated regularly and local news sources will
be kept informed as well.

# MONTHLY PASSES ONLY AVAILABLE THROUGH TOUCHPASS

January 1, 2020, LTD will no longer sell paper monthly passes. All monthly fare will require the TouchPass mobile app or tap card.

Now is the time to download the TouchPass mobile app or purchase an electronic tap card!

Electronic tap cards are available for \$3 at the LTD Customer Service Center (CSC) located at 1080 Willamette Street, Monday – Friday, 7:00 a.m. – 7:00

p.m. Electronic monthly passes can be purchased at CSC

or through an online TouchPass account. To use the mobile app, download the 'TouchPass Transit' mobile app from the app store, select LTD as the provider, follow steps to set up an account, and purchase your monthly pass.

While TouchPass is a convenient way to pay for fare, LTD will continue to accept cash from riders to pay for fare.

LTD Connector Pilot Program Extended

February 2, LTD will resume regular weekday bus service within Cottage Grove.

The LTD bus will again travel from Walmart through the center of town and back to Walmart before departing for Eugene on all days of the week.

LTD additionally plans to extend the LTD Connector pilot program through August 2020 within the city of Cottage Grove: Monday through Friday, from 7:00 a.m. to 7:00 p.m. Fares for the Connector are \$1 per ride through the duration of the pilot program, and all other LTD fare is also accepted.

# TRANSIT TOMORROW LTD Wants To Hear From You

Transit Tomorrow is a project looking at the best way to design our transit system. LTD is asking for your feedback to help guide LTD to the best service for the community.

The last LTD system review happened 20 years ago. Transit Tomorrow provides an opportunity to collaborate with the community, take a comprehensive look at the system, and gather feedback. Since 2018, more the 62,000 local residents have participated in public meetings, media outreach, online engagement, surveys, and received printed materials about Transit Tomorrow. Based on information from those outreach activities, the LTD Board of Directors made a key decision between investing resources to provide frequent bus service in areas where the most people are likely to ride (ridership) or prioritizing service to reach as many neighborhoods and commercial areas as possible (coverage).

Increased transit frequency along corridors supports local and national initiatives to help reduce the number of cars on the road resulting in lowering greenhouse gas emissions and reducing traffic congestion.

In addition, Transit Tomorrow is expected to inform the development of a new bus system to provide more frequent access to bus service to employment, people experiencing poverty, seniors, and all residents. LTD has a very complex goal to accomplish meeting community needs with the resources available, understanding there are trade-offs.
